## JUDGING CRITERIA

### For Conservation Projects

To assist entrants when assembling submissions, the judging criteria to be used in evaluating projects in Heritage Engineering are outlined as follows:

**1. Relative to Engineers Australia's purpose of "advancing society through great engineering."**

The extent to which the project contributes to social and economic benefits and/or quality of life within the community at local, regional or national levels. and,

How the project has conformed to the current relevant legislation and standards and has followed the guidance provided by "Conservation of Australia's Heritage - An Engineers Guide", the Burra Charter or other relevant documents.

**2. Formulation of resourceful, innovative, and elegant engineering solutions and/or pioneering use of materials and/or methods**

The significance of the project as a benchmark of Australian engineering. How it demonstrates innovation and sets new benchmarks, thereby raising the standard and standing of Australian engineering relevant to Heritage Engineering.

**3. Contribution to sustainable, inclusive and ethical practices**

How the project has incorporated sound contemporary ethical, environmental, health, safety, and security principles including EA's purpose and strategic vision. and,

What contribution to the support and recognition of equity, diversity and inclusion is apparent in the engineering of the project.

**4. Extent to which the work has delivered excellence**

The highlights or key successes of the project. and,

How it has delivered engineering excellence within the scope of the submission.

### For Documentation Projects

To assist entrants when assembling submissions, the judging criteria to be used in evaluating projects or work(s) in the Documentation of items of Engineering Heritage are outlined as follows:

### **1. Relative to Engineers Australia’s purpose of “advancing society through great engineering.”**

The extent to which the work contributes awareness of Engineering Heritage and social benefit and/or quality of life within the community at local, regional or national levels. and,

The extent to which the work has followed the guidance provided by “Conservation of Australia’s Heritage - An Engineers Guide”, particularly in relation to intangible heritage.

### **2. Formulation of a resourceful, innovative, and elegant solution and/or pioneering use of a method.**

How the work demonstrates innovation and/or presents a high standard. and,

The extent to which it contributes to the store of records in Australian Engineering Heritage.

### **3. Contribution to inclusive and ethical practices**

How the work has incorporated sound contemporary ethical principles including EA’s purpose and strategic vision.

### **4. Extent to which the work has delivered excellence**

The highlights or key successes of the product and how it has delivered engineering excellence within the scope of the submission.

### **5. Other Relevant Information**

Any further information relating to the work product that exemplifies its importance to modern engineering practice and the guidance it affords to current professionals in the specifics of their specialisation.

## **TERMS AND CONDITIONS**

- Nominations may be made by any unit or member of Engineers Australia
- The project must have been completed within a reasonable time before the closing of entries for judging so that it still possesses a reasonable degree of currency
- Nominations and submissions will be treated as confidential to the EHA Board
- This award is open to members and non-members of Engineers Australia
- The decisions of the Judges is final, no correspondence concerning their decisions shall be entered into.

## **SUBMISSION GUIDELINES**

- Submissions should address all the selection criteria where relevant and will encompass at least one of the criteria in substantial detail.
- Submission information shall be provided by attachment to the submission nomination form, where specified.
- There is are no limitations on the size of attachments.
- In total, written submissions should not exceed 6,000 words or 12 pages in 12 point (Arial or Times New Roman) excluding attachments.
