The Foundation is governed as per Swiss law, with Dominic Williams serving as the President and sole controlling person.

Screening confirmed no adverse information on governance or control.

The waiver of the identification document requirement for the controlling person was justified and did not compromise the completeness of the assessment.

5. Independence from Other Node Providers

Based on the signed self-declaration and verification through publicly available sources, it was confirmed that:

- Neither the controlling person nor any person with effective control holds similar positions in other Node Providers.
- There are no direct familial, corporate, or financial relationships with other Node
 Providers or their controlling persons.
- The Foundation is not part of a holding, parent, or subsidiary structure that includes other Node Providers.
- The Foundation has sufficient financial resources to independently generate and sustain network operations.

6. Additional Remarks

No material compliance, reputational, or legal risks were identified during the

Enhanced Due Diligence.

Minor historical disputes (e.g., intellectual property litigation and token-related

allegations) were either settled or dismissed and do not pose a current compliance

or reputational risk.
