## Director's Reports

**Chair** - Victoria Reynolds - The Unconvention was a wonderful town hall type meeting. The many volunteers made this work. The sold out Jo Jorgensen rally was excellent. Many candidates spoke. Victoria was able to give a great speech.

**Vice Chair** - Eric Mulder - He has many Jo Jorgensen materials available for distribution.

**Treasurer** - John Hjersman - In addition to his report, he wanted to thank Joe Johnson and Eric Mulder for their fundraising efforts. \$8,000 was raised in addition to the admission fees. The Jo campaign will be paying \$1586 for the provided facilities. Victoria noted that despite the government shutdowns, we made money on the convention. **Campaigns** - Bruce Griffith - The last date for new candidates has passed. We have 62 candidates running! They cover all available federal seats. The Blue Book legally closes on the 21st. He would like candidates to provide contact information for our website. The Pueblo Latino Chamber of Commerce would like to provide a video segment for candidates in their area.

**Outreach** - Mark Cavin - He will be contacting affiliate leadership to start a monthly Zoom. Klopf asked if Mark could provide an outreach booth at the debate.

**Affiliate Development** - Steve Gallant - He asked about the Umbrella protest in Pueblo. He's looking for new people in Delta.

**Legislative** - Matthew Hess - He has contributed to the Blue Book. He asked that we adopt his ballot issue positions. Spalding asked that these be included in the newsletter. Pickerill moved that we adopt the ballot issue recommendations. It was adopted without objection. There was a motion to split this into 11 different motions. Against: Vice, Treasurer, Outreach, Affiliates, Legislative, Communications, Secretary. For: Membership. This secondary motion failed.

**Membership** - John Pickerill - We continue to have an all time high number of volunteers. He reminded all affiliate and board members to provide content to Newsletter@LPColorado.org. The deadline is October 9th.
