As per our Bylaws Article II, Section 1, the duties of the State Chair are as follows: The State Chair shall be the chief executive officer of the Party, holding the powers of administration pertaining to the ordinary business affairs of the Party and such other powers as may be delegated by the Board of Directors. The State Chair may appoint such Party functionaries as a recording and corresponding secretary, an office manager, and an events chair. The State Chair shall compile, maintain and make available to the Board of Directors a publication listing all "Standing rules" and "Special rules" adopted by the Board of Directors. The State Chair shall specify the date and time of the next Convention at least 45 days before it is convened. The State Chair, or his or her designee, including other Board members acting within their designated job duties at the direction of the Chair, shall be the person who shall communicate on behalf of the Party. The State Chair shall file any amendments to the Party's Constitution or Bylaws with the Secretary of State within fifteen days after such amendments are adopted.

Communications Director Report for December, 2022

Per Bylaws Article VI, Section 3, subsection f, “The Communications Director shall be responsible for all outward-facing communications, websites, multimedia, social media, press releases, media appearances, and media inquiries. The Communications Director may establish and manage committees (including the appointment of any committee chairs) to accomplish these and other communications functions.”

I regained control of the master admin account for our Meta social media assets.

I opened a trouble ticket with Meta to investigate access issues I began to incur once the Meta business suite was rolled out. I could no longer view or access some administrative tools, such as seeing who was assigned a role on the page and being able to change their status.

Meta notified me that I was not assigned as the “Business Page Owner”. This title holds ultimate authority over the Meta assets: Instagram and Facebook.

I asked members of the board and those involved in prior party business, such as Caryn Ann and Wayne Harlos, and they were not aware of who the “Business Page Owner” could be. The Harloses asked around, and led the effort; such as inviting Amy Lunde and Ken Wyble to a group chat with myself and Vice-Chair Hannah Goodman. Amy was not aware of who it could be either. Ken never responded.

Gavin and I searched our email accounts for a clue as to who this person could be, but it was unsuccessful.

I then went through the Meta process of disputing the administration of the Meta assets and assign me as the “Business Page Owner”. After the collection of identification and verification of title, justification and authority, Meta assigned me as the new “Business Page Owner”. The former “Business Page Owner” was Lance Coyko. No effort was made to reach out to Lance as I did not know he held the previous title until I gained control.

Below are analytics from our social media accounts. TikTok and YouTube remain stagnant as they are not being utilized at this time due to resource constraints. The percentages in parathesis are month over month changes:

Twitter purged a large number of bots. Our twitter account saw approximately 400 accounts drop from our follower list. However, we made up that gap, and still added nearly 300 net new follower.
