1. Call to Order:

Chair Charles Melchin called the meeting to order at 10:04 AM. A quorum of the Executive Committee was present.

3. Public Comment: No comments.

4. Approval of Minutes:

a. Executive Committee Minutes (07/24/2021)

Jeff Hurley made a motion to approve the July minutes as written. Katie Banuelos seconded the motion. With no objections, the motion carried.

b. Executive Committee Minutes (08/28/2021)

Charles Melchin made a motion to approve the August minutes as written. Bryan Elliot seconded the motion. With no objections, the motion carried.

5. Reports:

a. Officer Reports:

i. Chair's Report

Charles Melchin reported that the national party had released a tentative delegate count for the next convention, and Nevada was slated for 14 delegates. He noted that the state could increase that delegate allotment if about 20-25 more Nevada residents joined the national party as dues-paying members before the end of October.

ii. Treasurer's Report (written reports attached on pages 5 & 6)

Bryan Elliott reviewed the financial reports through the end of September and provided an overview of the recent expenditures and revenues. The executive committee reviewed the following written reports:

iii. Secretary's Report

Katie Banuelos had nothing to report but noted that the meeting agenda had been revised to include an additional item of new business.

b. Target Metrics Report:

Jeff Hurley reported that he had recently learned that the Secretary of State's Office did not track historical voter registration, so the graphs he had presented at the last meeting were inaccurate. He also explained that the SOS Office had recently cleaned up their voter rolls, which resulted in all parties losing registered voters. He reported the following metrics:

- Registered Voters: 17,156 (about .95% of total)
- Active Members (on the party Discord Server): 75
- Email Newsletter Subscribers: 2747
- Dues Paying Members: 145 (+2 since the last meeting)

c. Director Reports:

i. Events and Outreach:

Sam Toll had nothing to report.

ii. Communications:

Katie Banuelos reported that the new website had been published and that the next project would be adding a store page. In September the party had successfully published an op-ed in the NV Independent on vaccine mandates and issued the first episode of the revived Battleborn Libertarians Podcast. There had been an all-hands meeting on 9/25 that had been sparsely attended. The next focus for the communications team will be to ensure weekly blog posts are issued.

iii. Tech:

Brad Carpenter experienced connectivity issues and left the meeting without delivering a report.

iv. Elections & Fundraising: (presentation attached on page 7)

Brandon Davis delivered a presentation on the current activities of the Elections Committee. Sam Toll noted that his district was not included on the list of favorable districts to target and asked for more details. Brandon Davis clarified what metrics were used in his dataset to indicate favorability.

v. Judicial Committee Organizing:

Bryan Elliot had nothing to report.

d. Affiliate Reports:

i. Clark County:

Jeffery Hurley reported that the Clark county affiliate website had been redesigned in conjunction with the state party website. He had established a Google search console and analytics and will be sharing it with Brandon Davis. He will also be establishing a Gab and MeWe presence for the party. He noted that new "Do Not Comply" t-shirts had been printed (at no cost to the party thanks to volunteer labor and donations) for distribution at upcoming events. He also reviewed his plan for upcoming Clark County events and next steps.

ii. Douglas County

Katie Banuelos reported that Charlie Holt had formally resigned his position as the Douglas County Chair on August 30, 2021.

iii. Washoe County (written report attached on page 13)
Katie Banuelos reported that Chris Orton had been unable to attend the meeting due to a work conflict, but had submitted a written report. She read the report aloud for those present.

6. Old Business:

a. Discuss management of state and county financials: (policy attached on page 14)
The executive committee discussed the *Proposed LPNV Distribution Policy* prepared by
Bryan Elliott. Jeff Hurley made a motion to adopt the policy. Katie Banuelos made a motion
to revise policy item 7 to allow any executive committee member to request a vote, rather
than only the treasurer. Bryan Elliot seconded the motion to amend. Hearing no objections,
the amendment to the policy passed. Katie Banuelos seconded the original motion to adopt
the policy. With no objections, the motion carried and the amended policy was adopted.

7. New Business:

a. Plan 2022 State Convention:

Charles Melchin suggested Saturday, February 26th, 2022 as a potential convention date. He noted that this weekend would allow 30 day's notice to be provided outside the holiday season, and was several weeks before the filing deadline for non-judicial candidates. The executive committee agreed this date would work. Sam Toll noted that historically the convention locations had alternated between the north and south of the state and asked whether that tradition would be upheld. Katie Banuelos pointed out that the upcoming national convention would be held in Sparks, which would put many southern residents in the position of needing to travel north twice within the span of a few months. She suggested holding the convention in Las Vegas and a satellite location in Washoe county. Bryan Elliott noted that two venues would increase the cost of the event. He made a motion to form a convention committee to plan the event. Both Charles Melchin and Adam Haman noted the value in coming together as a community annually. Katie Banuelos noted that alternating locations would result in candidates always being chosen in one area and executive committee members always being selected in the other. Charles Melchin proposed that the convention committee prepare three alternative scenarios (north, south, and concurrent/split) to present to the executive committee at the next meeting. He also suggested sending out a survey to the dues paying members for their input. Jeff Hurley

seconded the motion to form a convention committee. With no objections, the motion carried. Bryan Elliott volunteered to serve as the convention committee chair, and Jeff Hurley, Sam Toll, and Katie Banuelos volunteered to serve on the committee. Katie Banuelos made a motion to prohibit the use of any venue that would enforce mask or vaccine requirements on the participants. Bryan Elliott noted that this might drastically limit the available venues. Jeff Hurley seconded the motion. With none opposed, the motion carried.

b. Discuss status of Douglas County Affiliate and take actions deemed appropriate:

Katie Banuelos explained that with the resignation of Charlie Holt the affiliate was almost completely unstaffed and met the criteria to be considered "inactive" per the county affiliate bylaws. She explained that in these circumstances the bylaws provided a mechanism for the state party to assume leadership of the county affiliate. Charles Melchin noted that at the original organizing convention only three officers had been elected despite a bylaws requirement for five members. He asked whether it would make sense to revive the affiliate through state action if there might not be enough organic interest among the membership. Katie Banuelos reported that there were two volunteers present who had expressed interest in serving on the committee and working to revitalize the affiliate. She made a motion to ask these volunteers to recruit five members to serve on the county executive committee by the date of the next state executive committee meeting, with the state party to consider taking action if this is accomplished. Jeff Hurley seconded the motion. With none opposed, the motion carried. Lynette Warren and John Kennedy both affirmed their willingness to take on this project.

c. Discuss reciprocal membership agreement with LP National:

Jeff Hurley explained that the national party hosts a 'Unified Membership' program that allows people to join both the national and state level party at the same time through the national website. Charles Melchin noted that there were at least 90 Nevada residents who were dues paying members at the national level without being dues paying members at the state level, and suggested that joining this program might help prompt those people to consider state party membership. Katie Banuelos made a motion to enroll the state party in the LP National Unified Membership program. Jeff Hurley seconded the motion and volunteered to establish the program. With no objections, the motion carried.

8. Future Meeting Schedule and Calendar Updates:

The executive committee agreed to schedule the next executive committee meeting for Saturday, November 13th, 2021 at 10:00AM. Sam Toll spoke on the benefits of having an executive director and requested that the appointment of an executive director be added to the agenda for the next meeting.

9. Adjournment:

Jeffery Hurley made a motion to adjourn. Adam Haman seconded the motion, and with no objections the meeting was adjourned at 11:56 AM.



Washoe County Affiliate Report:

The Libertarian Party Washoe County affiliate is doing well with informal meetings regularly (i.e., every other Thursday as well as monthly movie nights and other special meetups ads appropriate. We are getting quite a few new folks who show up to these various meetings and events.

We hope to translate this into further involvement around the long term northern Nevada libertarian movement including the national convention in May. Some have contacted us with involvement in the national convention as their specific priority. Others have joined our group to network for when mainstream society breakdown at various levels. The hope is to be linked to others who are like-minded but have other skills or specializations. We are trying to facilitate both of these.

Disbursement Policy for the Libertarian Party of Nevada

(as originally drafted)

Proposed for the consideration of the LPNV Executive Committee:

- 1. While recognizing our limited current resources, the LPNV wishes to support efforts of its members to grow the number of Libertarian Party members via outreach events.
- 2. Any state/local committee or county affiliate recognized by the LPNV can apply for funding for party building events directly to the Treasurer of the LPNV.
- 3. The Treasurer will use his judgement to try to calculate the potential return on investment for the funding request.
- 4. If said request does not exceed \$100, the Treasurer will make the fund/don't fund decision using that ROI judgement.
- 5. For any request between \$101 and \$499, the Treasurer will solicit input from at least 2 other members of the Executive Committee, and will fund the request with the agreement of at least 2 of the 3 ExCom members whose opinion was solicited.
- 6. Any requests of \$500 or more would require a majority vote of the entire Executive Committee. Such a vote can be conducted electronically.
- 7. The Treasurer will request that the thresholds be raised or lowered by a majority vote of the ExCom should the financial position of the LPNV change materially in the opinion of the Treasurer. -
