1. Call to Order:

Chair Jeff Hurley called the meeting to order at 3:04 PM via Brave Talk. The Executive Committee was present.

2. Roll Call:

3. Public Comment: No comments.

4. Approval of Minutes:

a. Executive Committee Minutes (3/24/2024): Approved by acclamation.

5. Reports:

Officer Reports:

- i. Chair's Report: Jeff Hurley reported focus would shift to candidate support, the 2024 Voter's Guide, National Convention preparation and Freedom Fest support. Chair Hurley also stated he was looking for opportunities to support smaller counties with events. Chair Hurley also planned to reach out and confirm all convention delegates were set to attend the National Convention.
- **ii. Vice-Chair's Report:** Adam Haman reported on the upcoming FreedomFest and coordination with the Festival's volunteer captain for Party volunteers to work at the event. He also reported LP National would make 'Voter Gravity' app, tools and data available at reduced cost for Nevada candidates.
- iii. Treasurer's Report: Travis McGlothin reported a current cash balance of \$12,093 as of 4/28/24. Monthly expenses totaled \$3,930 and donations totaled \$3339 of the expenses were for the State Convention venue. \$1572 (including recurring donations of \$337 from 11 different donors). He noted the variance was due to the Convention dues and costs.

iv. Secretary's Report: Brenda Barozzi reported some transition issues with using the server (access and functionality). Also in transition, letter to NV SOS still is pending but needs to be done prior to the August Presidential Filing.

She also noted the Presidential Filing needed to be completed by 3rd Tuesday in August with a list of 6 electors and 6 alternates to the SOS. Electors will be addressed in Q2 after National Convention.

b. Director Reports:

- i. **Legislative:** *vacant.* Chair Hurley noted there was no current legislative session.
- ii. Communications: Brenda Barozzi reported the weekly update continues.
- iii. **Tech:** Brad Carpenter had nothing to report
- **iv. Elections:** Jesse Welsh reported he was dropping his own campaign to focus on candidate support.
- v. Fundraising and Volunteer Coordinator: Jeff Hurley reported that there would be virtual town halls for Libertarian Presidential Candidates. Jeff Hurley also discussed the "brigade" fundraising plan begin prepared for launch.

c. Affiliate Reports:

- ii. Douglas County: Dave Jones was not present.
- **Washoe County:** Chris Orton reported the upcoming Executive Committee meeting and the ongoing support of Range day, Circle Bastiat and other meet ups.

6. Old Business:

a. Voter Guide Agreed to the beginning a committee formation including Brenda Barozzi (research/surveys), Jeff Hurley and Adam Haman (final product). It was agreed to focus on after the primaries are finished (June 11, 2024). It was agreed to update the 2024 survey and to exclude judges: planned steps: creating a revised survey, gather list and contacts of candidates to be surveyed, deployment, follow up, and written publication.

b. Candidate Support

Jeff Hurley discussed redoing the candidate listing page and was verifying web content for links. Discussed mock debates and inviting candidates to meet-ups.

7. National Convention Preparation

Chairman Hurley stated he would check the delegate list to make sure everyone was set with travel plans so any alternates could be alerted if needed. He also stated he shared our NV bylaws with the national convention so they would govern our us of alternates. National Party is taking bids for better delegate seating placement, and it was discussed as to whether we would attempt to use the process. Adam Haman suggested we could make a \$100 donation. It was discussed that the delegates would be reached out to and the donation levels monitored to decide if it was worth doing. Cut off is 5/11/24.

10. Future Meeting Schedule and Calendar Updates:

The executive committee agreed to schedule the next state executive committee meeting for Sunday, June 2, 2024 at 3:00PM. Adam Haman motioned for, second by Travis McGlothin.
