The meeting was called to order at 7:06 p.m. by Daniel Castello, Vice-Chair. Secretary Andrew Kolstee conducted a roll call and determined that a quorum was present.

Andrew Kolstee issued a Secretary's report.

Duane Whitmer issued a Chair's report. He reported that Larry Sharpe had under 1,500 signatures on the Coalition Party line, which is not enough to get on the ballot. He is now pursuing a lawsuit. It was the intention of the Chair to be silent about the LPNY's plans, out of respect for Larry Sharpe's previous campaigns under the Libertarian Party. The Chair reported other potential developments in the statewide campaigns. He announced a plan to pursue a "None of the Above" write-in campaign. There was a discussion on strategies surrounding local candidates.

Communications Director Christopher Skelly issued a report. He will have a written report later this week. The Chair requested that a donate link be included in social media posts.

The Chair would like to send a fundraising mailer out to all enrolled Libertarians in the state and send press releases to promote wins.

The Chair would like to redesign the website and provide more educational information on it. Christopher Skelly and Daniel Castello volunteered to help with the website.

Legislative Affairs Director Richard Purtell issued a report. One major upcoming issue is a constitutional amendment that would have redistricting occur once every five years. The Chair reported on the Ballots Without Barriers presentation at the Libertarian National Convention. A meeting with the organization will need to be scheduled. The Chair would like to send a questionnaire to all members of the Assembly and Senate.

Outreach Director Pietro Geraci issued a report. He reported that UniteNY is close to placing Ranked Choice Voting on the ballot. There are several people who have reached out about establishing County Affiliates. He reported that Nathan Dingey has resigned as Acting Chair for Ontario County. The Chair requested a list of upcoming local fairs and festivals.

Political Director Paul Grindle issued a report. He will be searching for Libertarian candidates who may be on the ballot this year. He also had a conversation with Harrison Kemp of Ballots Without Barriers.

Volunteer Director Catrina Rocco issued a report in writing (**Exhibit 1**).

Andrew Kolstee reported that New York is part of LNC Region 9 with New Jersey, Illinois, and Wisconsin.
